## HOW IS GREG ALLEN FUNDED AND HOW HAS HE SPENT THE MONEY COMING INTO "FRIENDS OF GREG ALLEN"?

My financial reporting is now working between the Virginia Board of Elections and VPAP (Virginia Public Access Project) that provides financial reporting on all candidates.

As an independent, I announced just before the deadline of June 22, 2023. I did not officially retire from Chesterfield County Planning Department until July 31, 2023. I was not seeking any campaign funds while I still had access to county staff and systems. I had a few short weeks where I actively pursued donations but now it is just donations through my website. It is too short a time to worry over \$100 donation increments which is the maximum amount I accept.

Why am I personally underwriting my campaign? I have had a great 40-year career and the last 30 years have been paid for by taxpayers. At this point, some of the money I have saved needs to go to a higher calling. I take this seriously as citizens have no idea how Chesterfield will become urbanized, overcrowded, and out of control with no vision for the quality of life we hope to enjoy. It is the Fairfaxing of Chesterfield.

Of all the candidates in this election for Board of Supervisors, I am the candidate who has the knowledge, experience, and abilities to guide the Board and change our direction to focus on the quality of the county and to slow down residential growth. I wrote most of the quality standards in our zoning ordinance and I know how the regulations for zoning and development have been ignored over the last four years by the acting Planning Department, Planning Commission, and Board of Supervisors. I had to leave that environment to fight this by getting elected to the Board. From there I can bring to light and correct the activities that should not be occurring.

Financially, it is worth it to me to give this money back to protect our citizens and our county's future. If I lose this election, then everything will continue as it has over the past four years and we will eventually be like Fairfax.

In terms of donations, the Virginia Board of Elections does not report who gives when the donation is no more than \$100 in total over the course of the campaign. That is another reason why I capped donations to my campaign at \$100 so I can protect any Republicans or Democrats who want to support me.

This offers a good comparison. Since 2015, Chris Winslow has received more than \$200,000 from the development community out of \$400,000 in total donations. Politics is big money, but that is not my approach and will not be if I get elected. I will maintain a \$100 cap on any donations in aggregate from individuals or businesses.
